- 4. The programs have been granted accreditation for 3 years. A.V.C. College of Engineering, Mayiladuthurai, Mannampandal, Nagapattinam District, Tamil Nadu-609305 should submit the Compliance Report at least six months before the expiry of validity of accreditation mentioned above so as to be eligible for consideration by the concerned Committee in NBA for further processing of the accreditation status.
