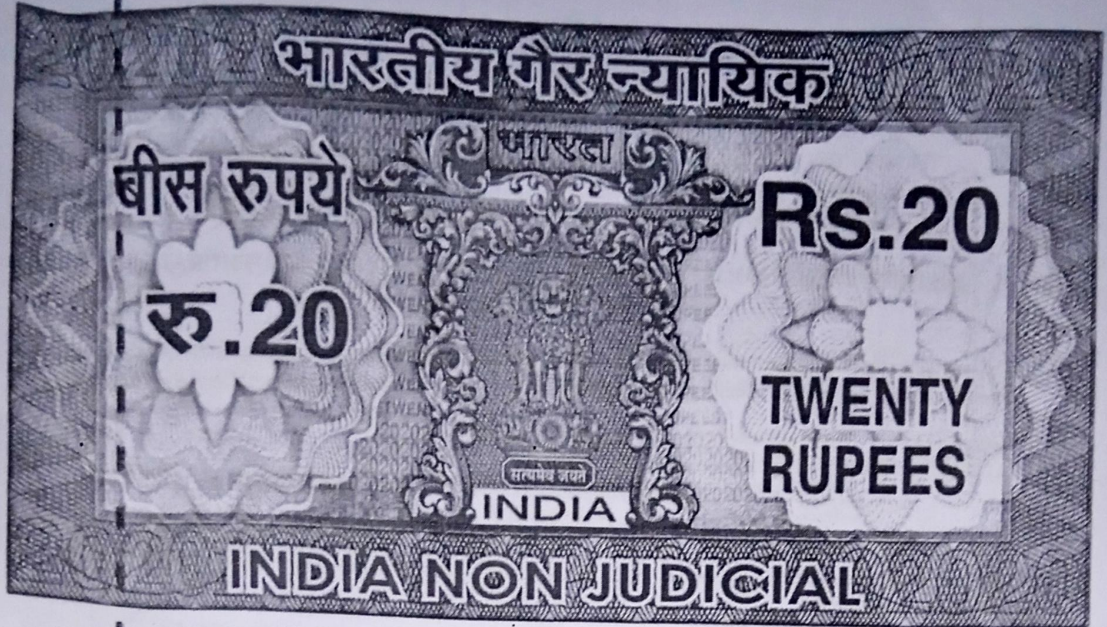



**CLAUSE 4****RELATIONSHIP BETWEEN THE PARTIES**


